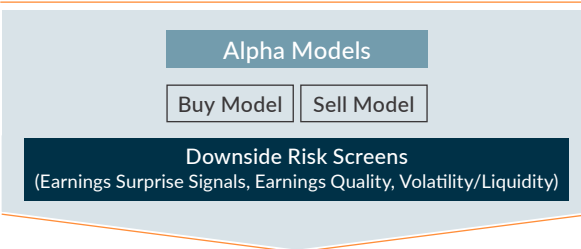

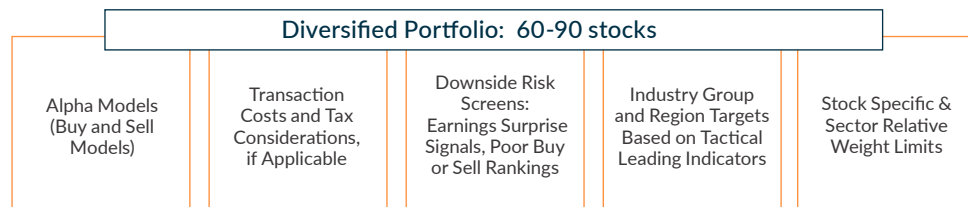


Portfolio Positioning
