We believe a diversified portfolio of international stocks may achieve long-term returns through capital appreciation, dividend income, and management of downside risk.

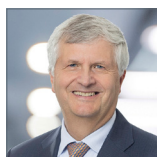
**Investment Strategy**

- Focuses on underperformance risk as much as outperformance opportunity.

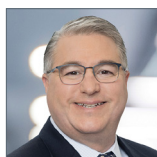

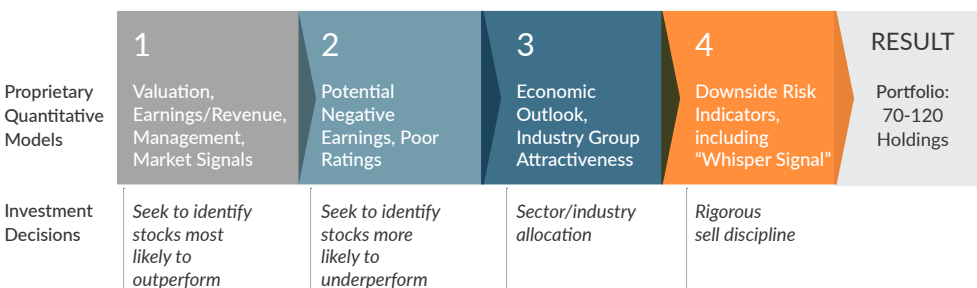
