Information Ratio: ratio of expected return to risk, as measured by standard deviation. Sharpe Ratio: sharpe ratio is a simple measure-ment of the risk-adjusted performance. Price to Book (P/B): ratio of stock price to per share shareholders' equity. Price to Earnings (P/E): ratio of stock price to earnings. Batting Average: batting average is calculated by dividing the number of quarters in which the manager beats or matches the Index by the total number of quarters in the period of question and multiplying that factor by 100. **Return on Equity (ROE)**: net income divided by equity. **Standard Deviation**: measures dispersion of a set of data from its mean. **3-Year EPS Growth**: annualized historical earnings per share growth over the last 3 years. EPS Growth is not a forecast of the fund's future performance. Tracking Error: measures the active risk of the portfolio and the annualized standard deviation of the excess returns between the portfolio and its benchmark. Weighted Average Market Cap: total value of all outstanding shares weighted to reflect the portfolio's positions. Dividend Yield: the ratio of a company's annual dividend compared to its share price. The S&P 500 Index consists of 500 widely held common stocks. This unmanaged index is a total return index with dividends reinvested. One cannot invest directly in an index.
