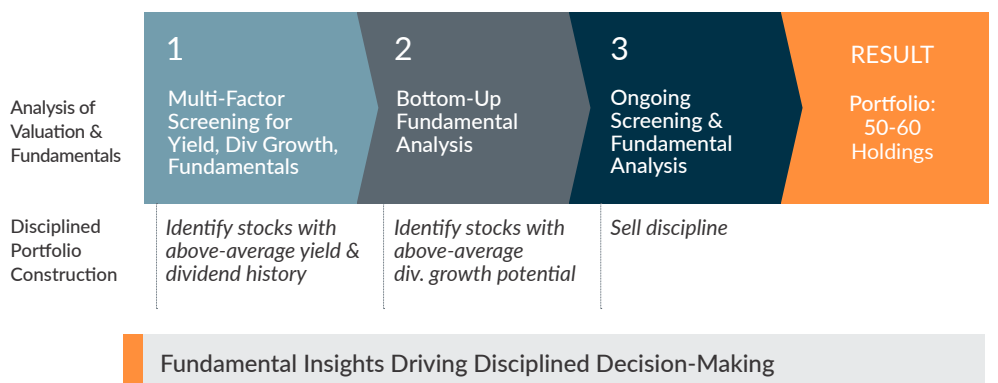

EPS Growth is not a forecast of the fund's future performance. **Tracking Error:** measures the active risk of the portfolio and the annualized standard deviation of the excess returns between the portfolio and its benchmark. **Weighted Average Market Cap:** total value of all outstanding shares weighted to reflect the portfolio's positions. **Dividend Yield:** the ratio of a company's annual dividend compared to its share price. The S&P 500 Index consists of 500 widely held common stocks.
